## **Hurricane Rita Update**

Hurricane Rita stormed into Texas and Louisiana at 2:30 AM CDT this morning, with winds of 120 MPH, sheets of rain and battering waves that flooded coastal communities, uprooted trees and tore apart numerous buildings. As of 10:00 AM CDT this morning, Rita was losing punch fast and is expected to produce torrential rains during the next few days. A tropical storm warning is in effect from High Island, TX to Morgan City, LA. At 10:00 AM CDT, the center of Hurricane Rita was located midway near Jasper, TX. Rita is moving toward the north near 12 mph and this motion is expected to continue for the next 24 hours. Maximum sustained winds have decreased to near 75 mph with higher gusts. Rita is a Category One hurricane and weakening is forecast during the next 24 hours. Hurricane force winds extend outward up to 35 miles from the center and tropical storm force winds extend outward up to 140 miles. Rita's slow movement is expected to generate very heavy rains over the next few days, with rainfall totals of 10 to 15 inches possible across eastern Texas, western Louisiana and southern Arkansas. Maximum rainfall totals in excess of 25 inches may occur over localized areas. Rainfall amounts of 3 to 5 inches with isolated heavier amounts are possible over southeastern Louisiana including Metropolitan New Orleans. Isolated tornadoes are possible today and tonight over far eastern Texas, Louisiana, southern Arkansas and Mississippi.

The mayor of Lake Charles, LA has declared a curfew in the city from 7:00 PM to 6:00 AM.

## **Rita Impact**

• Central Point Energy reports that as of 10:00 AM CDT, on Saturday, Sept. 24, 600,000 of their 1.9 million customers were without power, down from a peak of more than 700,000 at the height of the storm. Most of the damage was caused by intense wind, lightning, and flying debris caused by toppled trees and large branches falling on power lines. Entergy reports that a total of 333,150 of their customers were without electricity at 9:30 PM CDT last night. This includes customers still out due to Hurricane Katrina and more than 55,000 new outages due to Hurricane Rita.

## **Red Cross Preparations for Rita**

## DR 865-06 (Louisiana)

The following is an update on **Louisiana's "at risk" chapters and areas** (feeding operations have been secured and meals are being provided by local agreements and pre-positioned meals):

- The American Red Cross of Southwest Louisiana in Lake Charles, LA has evacuated the Convention Center and Barton Center shelters in Lake Charles to Monroe and other smaller locations along with shelter staff. The ERVs have moved north to assist those Red Cross shelters that are outside the storm surge risk area. The staff is buckling down at their COOP location in South Beauregard HS.
- The Acadiana Area Chapter in Lafayette has moved their operations to the EOC in Lafayette Parish. Shelters and staff evacuated to Alexandria and Shreveport shelters. Food is positioned to support chapter shelters in Opelousas area.
- The Southeast Louisiana Chapter in the Bayou Area at Houma is in constant contact with the Offices of Emergency Preparedness in their area. They have three shelters there and at this time there is no plan for evacuation. All kitchen, ERV and other staff in the area have been assigned to support shelter facilities and will be staying at that shelter facility. If an

- evacuation were required at the last minute, the OEP has plans and arrangements to evacuate the shelter and move Red Cross staff to a safe location. All EOCs are covered.
- The Southeast Louisiana Chapter in the Metro Area at Jefferson Parish staff is in close contact with OEP and monitoring the situation closely. At this time, there are no plans to evacuate. Plans are in place by OEP and Red Cross if an evacuation were required to the North Shore. Once there, they would support Red Cross operations in that area.
- The Southeast Louisiana Chapter in St. Bernard Parish has evacuated to Covington and is supporting operations on the North Shore.

#### The following is an update on **Louisiana's up-state chapters**:

- Central Louisiana Chapter in Alexandria, Northwest Louisiana Chapter in Shreveport and Northeast Louisiana Chapter in Monroe have opened their capacity of shelters and are currently populating those facilities with evacuees.
- Additional staffing and material resources have been sent from the DRO HQ to up-state chapters to assist with sheltering and feeding.
- Additional staff have been identified at the DRO HQ to assist in the opening of additional shelters in the Baton Rouge area.
- Red Cross shelters are expected to be filled by late afternoon/early evening. Clients will be directed to proceed further north into Arkansas and other states according to state officials.

# **DRO headquarters** plans for landfall and continuity of operations during the storm and subsequent passage:

DRO headquarters at the Wal-Mart location in Baton Rouge will shut down at 6:00 PM CDT tonight and all staff will secure in their staff shelters/hotels. A small contingent of DRO leadership staff (OM, MSS/Log, PS/Gov Liaison, CLS/Health Services, COS/Sheltering and Feeding) will set up at the Capital Area Chapter in Baton Rouge and will operate there until storm passage and it is safe to operate at the Wal-Mart DRO headquarters. Contact numbers are available from the DOC. We will inform you when we return to normal operations at the Wal-Mart DRO HQ.

#### DR 871-06 (Montgomery, AL)

- We will be focusing energies on feeding and sheltering in a safe environment. Our service
  centers will not be open, except for a few chapter exceptions. Our workers, especially those
  located south of Route 84 will be in safe structures or will be brought to Montgomery. Staff in
  Montgomery will not be deployed unless we need to support safe shelters. Staff remaining in
  Montgomery will do shifts of data entry into the Client Assistance System (CAS).
- One additional shelter opened today.
- All Client Assistance Centers were closed today due to Hurricane Rita and will remain so until it is safe for clients and workers to return.
- All kitchens are closed until Rita has passed.
- All route teams have been pulled.
- All distribution has ceased until it is safe to resume.
- All staff has been directed to return to their lodging and remain there until notified to return to work.

#### DR 307-06 (Mississippi Gulf Coast)

 Because of Hurricane Rita and related tornado watches and flooding along the Mississippi Gulf Coast, DRO headquarters will be closing and operations will run from our lodgings for approximately the next 24-36 hours. We will be communicating by cell phone. I will assess weather conditions constantly and reopen as soon as it's safe. All staff and vehicles are grounded under further notice.

## **DSHR Staffing**

- To date, **18,623** DSHR workers have been assigned to the **44** operations related to Katrina; **1,755** of them have been released.
- Yesterday, 523 DSHR workers were assigned to operations.
- A total of 13,072 staff cards have been loaded.
